FENG SHUI LOCKS

Many of my clients, looking to purchase or rent new properties, have asked for charts to determine if a potential home or business has an annual lock or a 20 year lock. They know from personal experience how powerful a "locked" situation can be. A lock means that the central 'invisible' energies within a building are the same as those outside of the building and the energy flow becomes restricted or imprisoned.

There are two types of locks; a money lock and a people lock. A money lock can bring career and financial problems, while a people lock can present constant obstacles in health or relationships. It is also difficult to conceive a child if a home has a people lock.

In a business, a people lock can make it hard to attract new customers or to keep employees. Locks often are the reason a home or business is hard to sell, and, I can usually see the reason the owners have to sell, especially if the building is sitting incorrectly according to the magnetic tides.

This information is also valuable for people who feel their life circumstances seem to be stuck. With the correct placement of moving water, and some other remedies, a lock can usually be lessened or removed.

To determine whether a building is locked or not, I use the Flying Star School of Feng Shui. It is a very dynamic practice and has methods to chart the movements and changes of the intangible energies around us. Flying Star Feng Shui incorporates both time and space to analyze a dwelling's "qi." The magnetic orientation of a structure, along with the year it was built (completion of construction) helps to reveal its past, present and future potential on several levels (physical, emotional, mental and spiritual.) It is truly a devic language.

To utilize these twenty year construction charts, you will need to know the year the building was built and the magnetic direction it “faces.” To get the magnetic direction, stand with your back to the front of the building and read the degree straight ahead on the compass. Try to personify the building to figure out it’s face! Usually it is where the front door is located, the main street, the most active side, etc. It is how the building looks out on the world. If in doubt, you can call me or email me to get assistance.

When shopping for your home or business, try to stay away from one with a 20 year lock. There are remedies we can do, but it’s better to try to avoid the problems.

When choosing a property, it is important to remember that “locks” are only one of many considerations. Besides the other Flying Stars considerations, there is also the wisdom and knowledge of the “Form School.” In the August Newsletter, we will look at annual “locks.” If you are looking for a new home or business, I hope this information aids you in finding the perfect location! If you find you are living in a locked situation, either people or money, hopefully this newsletter brings some comfort. You are not crazy!
